Your firm have failed to complete the supplies against the above P.O inspite of repeated reminders. 21 days notice was served upon your firm under "Negligence & Default" clause of purchase order vide memo no. 2907 dated 05.11.2014 but you have failed to complete the supplies as per the respective provision of the above Purchase Order. The matter was considered by the Whole Time Directors of PSPCL in its 200th meeting held on 23.11.2017 at Patiala and it has been decided as under:-
