Dear Sirs,

This has in reference to your offer submitted against TS no. 738 (eTender No.502) opened on 02.09.2016 for supply of Single Core L.T. XLPE Un-Armoured Cables.

As per Pre Qualification Requirement Clause No.14 of Annexure-II (Important Instructions' the Bidders), the minimum and maximum size of offered cables shall be fully type tested from NABL accredited lab as per relevant Indian Standards during the last five years from the date of bid opening. Submission of photo copy of the type test certificates for the tests conducted at CPRI, ERDA or any NABL accredited Test Lab is essential. Type test certificates of other than NABL accredited lab shall not be considered. In absence of NABL certificates the offer shall be liable for rejection. The decision of MPPKVCL in this regard shall be final and binding on the bidders.

In order to examine the genuineness and assurance of the above Test Reports, the copies furnished by you against the tender under subject were sent to M/s Delta Laboratory, 80-B, Prem Nagar, Indore-452007, vide this office letters No. 194 dtd.06.09.2016, for verification.

It is regretted to mention that after verification of the Reports, Shri Vishal Gupta Managing Director of M/s Delta Laboratory (NABL Accredited Electrical Testing Laboratory), Indore, vide their letters dtd.09.09.2016, has intimated following :-

"Test Certificate No. DLI/T/179 dtd. 02.03.2012 of 1Cx150mm² XLPE Cable has not been issued by us to M/s Bhadora Industries. Above firm has forged this certificate."

You have thus furnished fake type report for 1Cx150mm² XLPE Cable against our tender to meet PQR which is a serious matter and not acceptable by us. Therefore, by rendering an opportunity you are called upon to furnish your clarification within 15 days from the date of the notice letter no. ED/PUR/EZ/GM-I/II/2770 dtd.30.11.09.2016 as to why following action against you may not be taken as per terms & conditions of the tender :-

- (i) Black-list your firm and suspend all future business dealing with your firm.
- (ii) An intimation to DIC regarding submission of forged documents asking them to withdraw EMD exemption facility of your firm.
- (iii) An intimation to all SEBs/ Distribution, Transmission, Generating, Nigam & Companies regarding submission of forged documents.




