Subject: - **Blacklisting of M/s Janki Transformers, Bhiwani due to non-fulfilling of contractual obligations against contract no. WC-17 for repairing of amorphous core damaged distribution transformers of capacity 25, 63 & 100 KVA.**

A Letter of Intent vide this office memo no. Ch-186/COS/Amphs/NIT/WC-17

dated 18.02.2016 for repairing of amorphous core damaged distribution transformers of capacity 25, 63 & 100 KVA against tender enquiry no. WC-17 was placed upon your firm.

wherein, it was requested to submit the required bank guarantee of Rs. 10.00 Lacs within 15 days of issuance of this LOI as per terms & conditions of the tender enquiry. As per clause

no. 1 i.e. 'Bank Guarantee' of Annexure-B of tender enquiry no. WC-17, the firm has to deposit required B.G. within 15 days from the date of LOI, which should remain valid for a

period of 90 days after completion of the contract period including warranty period for faithful execution of the contract and safe custody of Nigam's property. However your firm did not submit the required B.G. in the stipulated time despite of repeated requests.

It is quite evident from the above that your firm failed in discharging its contractual obligations for repairing of transformers and liable for taking action as per terms & conditions of the tender enquiry for the aforementioned default. Accordingly, vide this office memo no. Ch-274/COS/Amphs/NIT/WC-17 dated 08.07.2016, a notice of blacklisting was

issued to your firm wherein you were asked to submit your reply within 15 days as to why your firm should not be blacklisted including taking action for forfeiture of your EMD etc. In reply, your firm vide letter dated 18.07.2016 intimated that "you got allotted tender in

Purvanchal Vidyut Vitran Nigam Limited (U.P.). Due to blockage of firm's payment in ibid department, it is getting late in submission of Bank guarantee against contract no. WC-17 and

Slanyour firm further requested to give 40 days more for submission of B.G.

The matter was deliberated by SPC, wherein request of your firm was not found tenable as already a period of more than 6 months of issuance of LOI elapsed whereas the currency of contract period itself is initially for 1 year. Accordingly, it was decided to take

action against your firm viz-a-viz Termination of LOI/ Contract placed upon your firm, blacklisting of your firm & forfeiture of your EMD etc. Accordingly, vide COS office memo no. Ch-56/COS/Amphs/NIT/WC-17/Vol-II dated 21.11.2016, a final notice was issued to your firm wherein it was requested to submit your reply within 21 days of issuance of this notice as to why action as per above said decision of SPC should not be taken against your firm. But, no reply of your firm received against the above said notice.

The aforementioned defaults by your firm of non fulfilling contractual obligations against repair contract no. WC-17 were considered by the SPC in its meeting held on 21.12.2016 and decided to take following action:-

1. Termination of LOI/ Contract placed upon your firm vide this office memo no.Ch-186/COS/Amphs/NIT/WC-17 dated 18.02.2016.
2. Forfeiture of EMD submitted by your firm.
3. To process the case for blacklisting of your firm for the above said default.

Hence the LOI/ Contract placed upon your firm was cancelled vide this office memo no. Ch-63/COS/Amphs/NIT/WC-17/Vol-II dated 2.01.2017. Further, action for forfeiture of EMD submitted by your firm has been already taken by the Nigam. Further, the above said defaults made by your firm were considered by the Whole Time Directors of the Nigam in their meeting held on 10.02.2017 and decided to blacklist your firm on account of default of your firm for non repairing of transformers against contract no. WC-17 & thus contravening the terms & conditions of the contract. Hence your firm titled with the name, "M/s Janki Transformers, Dadri Road, Behind Reliance Petrol Pump, Bhiwani-127021 (Haryana)" is hereby blacklisted due to default in fulfillment of contractual obligations against the aforementioned contract. This blacklisting will remain in operation for a period of 3 years from the date of issuance of this order.
