Dear Sir,

The subject cited Purchase Order No. HH-068/QQ-151/PO-C dated 06.02.12 for supply of 30 KM 11KV Aerial Bunched Cable of size 3C x 150mm<sup>2</sup> + 150mm<sup>2</sup> (Messenger Wire) was placed upon you. Your firm have failed to complete the supplies against the above P.O inspite of repeated reminders. 21 days notice was served upon your firm under "Negligence & Default" clause of purchase order vide memo no. 2907 dated 05.11.2014 but you have failed to complete the supplies as per the respective provision of the above Purchase Order. The matter was considered by the Whole Time Directors of PSPCL in its 200<sup>th</sup> meeting held on 23.11.2017 at Patiala and it has been decided as under:-

1. Purchase Order No.HH-068/QQ-151/PO-C dated 06.02.12 for the supply of 30 KM 11KV Aerial Bunched Cable of size 3C x 150mm<sup>2</sup> + 150mm<sup>2</sup> (Messenger Wire) is hereby cancelled for the balance supplies.
2. An amount of Rs. 3,22,930/- lying with MM organization as security along with amount of Rs.3,22,930/- retained from bills , both be forfeited.
3. An amount of Rs.10,00, 000/- deposited by you on the account of PEMD with MM organization is hereby forfeited.
4. Business dealings of PSPCL with your firm are suspended for a period of three years from the date of issue of this letter.


