Sub: Debarring of M/s S A Enterprises, Kolkata for submission of forged documents against Tender Specification Discom/EZ/Pur/855 (e-1343) opened on 30.01.18 for supply of earthing set (coil earth).

This has in reference to your offer submitted against the tender under subject and letter dtd.05.02.18 cited under reference vide which you have submitted copies of purchase order alongwith few MRCs and performance certificate towards supply of tendered item against supply capacity criteria, as required under Clause 1.1 (b), Annexure-II of the tender specification.

The documents submitted by you alongwith your offer and vide your above letter dtd.05.02.18 includes copies of the performance certificates issued by the Chief Engineer (Distribution Central), Kerala State Electricity Board vide No.CE(DC)/E-II/T-3/ Coil/ 14-15/1215 dtd.01.02.18 and CE(DC)/E II/T-3/Coil/12-13/792 dtd.09.04.15 towards supply of 50000 nos. GI earthing coil under purchase orders No.CE(DC)/01/2014-15/23 dtd.07.05.14 and 25000 nos. against purchase order no. CE(DC)/18/2014-15/76 dtd.07.08.14 and 15000 nos. under purchase order No.CE(DC)/i6/2012-13/76 DTD.16.10.12 respectively.

The issuance of above performance certificate dtd. 01.02.18 and 09.04.15 was got confirmed from the Chief Engineer(Distribution Central), Kerala State Electricity Board.

The Chief Engineer (Distribution Central), Kerala State Electricity Board, vide letter No.CE(DC)/E-VI/GNL/17-18/3905 dtd.03.03.18 has confirmed that his office has not issued any performance report dtd.09.04.15 and 01.02.18 and the purchase orders referred therein are not seen issued to the addressee furnished in the mail. It has been further indicated by him that the same PO No. is referred by both M/s SA Enterprises and M/s Sridhar Energy Pvt. Ltd. in the performance certificate dtd.09.04.15 which reveals that it is a fabricated one.

You have thus used unfair means by furnishing fabricated / forged documents for meeting eligibility criteria of the subject tender specification and the same was considered a serious default in your part. A show-cause notice was therefore issued to you vide No.CGM/PUR/EZ/GM-II/III/3567 dtd.22.02.18 to explain as to why following action may not be taken against you.

- (i) To debar and suspend all future business with your firm for a period of three years with intimation to all other SEBs/Discom/Power Utilities.
- (ii) To inform NSIC regarding submission of forged documents and asking them to cancel your registration with them.

In reply to our above show-cause notice dtd.22.02.18 you have confessed submission of above forged document, vide letter No.SAE/MPPKVCL/ 855/02 dtd. 27.02.18 and clarified that your Marketing Manager has committed this mistake without your knowledge with the intension to get as much business possible for your firm. The above clarification submitted by you has been examined and not found tenable to accept as the aforesaid forged documents are found attested by the Constituted Attorney of your Company.

It has therefore been decided that;

“Your firm M/s S A Enterprises, 5/1, Clive Row, 2nd Floor, Room No.34, Kolkata is hereby debarred for all future business with MP Poorv Kshetra Vidyut Vitran Company Limited, Jabalpur for a period of three years with intimation to all other SEBs/Discoms/Power Utilities.”
