Dear Sir,

The subject cited Purchase Order No. HH-1922/QQ-1256/PO/C&S dated 06.11.2013 and Purchase Order No. HH-1923/QQ-1256/PO/C&S dated 06.11.2013 for the supply of Multi core, LT, XLPE Cables and HH-1944/QQ-1261/PO/C&S dated 06.05.2014 for the supply of Twin core, LT, PVC Cable were placed upon you. Your firm failed to complete the supplies against the above P.O.s inspite of repeated reminders. 21 days notice was served upon your firm under "Negligence & Default" clause of purchase order vide this office memo no. 1192/HH-1922 dtd. 02.06.2017 followed by reminder memo no. 2984/HH-1922 dated 16.10.17. Irrespective of the above said opportunity of being heard given to you, you had failed to complete the supplies as per the provision of the above said Purchase Orders. The matter was considered by the competent authority of PSPCL and it has been decided as under:-

- 1. P.O. No. HH-1922/QQ-1256/PO/C&S dated 06.11.2013 and P.O. No. HH-1923/QQ-1256/PO/C&S dated 06.11.2013 placed on M/s Omega Transmission Pvt. Ltd., Kolkata for the balance quantity of Multicore, LT XLPE cable against respective POs is hereby cancelled
- 2. P.O. No. HH-1944/QQ-1261/PO/C&S dated 06.05.2014 placed on M/s Omega Transmission Pvt. Ltd., Kolkata for the balance quantity of Twin, LT PVC cable against respective POs is hereby cancelled
- 3. Security amount of Rs. 2,32,330/- (Two Lac Thirty Two Thousand Three Hundred Thirty only) towards 2% security against HH-1922/QQ-1256/PO/C&S dated 06.11.2013 deposited by the firm is hereby forfeited.
- 4. Balance amount of Rs 1,72,534/- (One Lac Seventy Two thousand Five Hundred Thirty Four only) towards 2% security against HH-1923/QQ-1256/PO/C&S dated 06.11.2013 deposited by the firm is hereby forfeited.
