

Blacklisting for a period of 3 years, on account for misconduct against P.O. No. HH-7817/RC-129/QH-II/1946/XEN/P-III/MM dated 29,09.17 and HH-7911/RC-129 /QH-II/1946/XEN/P-III/MM dated 13.12.2017 for the procurement of LT XLPE AB Cable of size 3CX95+70 sq. mm.

The Rate contract no. 129/QH-II/1946/XEN/P-III/MM dated 22.09.2017 was placed upon your firm for supply of LT XLPE AB Cable of size 3CX95+70 sq. mm resulting into a legally binding contract for a period of one year. Subsequently, a Purchase order no HH-7817/RC-129/QH-II/1946/XEN/P-III/MM dated 29.09.17 and HH-7911/RC-129 /QH-II/1946/XEN/P-III/MM dated 13.12.2017 were issued to your firm for supply of LT XLPE AB Cable of size 3CX95+70 sq. mm. On the request of your firm, inspecting officer was deputed for inspection but your firm

initially postponed the said inspection till 23.01.2018 vide E-mail dated 17.01.2018 and then extended to 30.01.2018 vide E-mail dated 23.01..2018. Inspecting officer visited your firm's premises on 08.02.2018 for inspection but the sample selected by him for inspection was changed by your firm and when inspector asked to bring the selected sample, representative of your firm refused and selected sample was not produced for testing inspite of repeated directions by inspector. Vide letter dated 10.12.2018, your firm admitted that delay in supply is on account of labour problem. Consequently on equest of your firm another chance was given to supply the material subject to deposit an additional Bank Guarantee @ 5% of the value of POs and deposit Rs. 2,50,000/- in advance as penalty but you अध्यक्ष, उ०प्र०पा०का०िलीत not fulfill the above condition. On account of breach of Contract, Rate contract/Purchase order was terminated vide letter dated 01.08.2019.

It should be noted that such a liability can be enforced on the supplier only if the purchase order does not contain any term or condition contrary to what had been quoted in the supplier's tender. Once this is ensured, any attempt by the supplier to back out of his commitment should be taken a serious and his earnest money deposited be forfeited forthwith, without prejudice to any further legal remedies open to the Nigam under the relevant laws. In response to which your firm vide letter dated 10.12.2018 shown willingness to supply the material but despite granting of another opportunity your firm failed to fulfill the contractual obligation. This essentially means that you are not interested to supply the material. Therefore, it has been decided by competent authority to blacklist your firm for a period 3 years on account of non-supply of material against P.O. No. HH-7817/RC-129/QH-II/1946/XEN/P-III/MM dated 29.09.17 and HH-7911/RC-129 /QH-II/1946/XEN/P-III/MM dated 13.12.2017 for the procurement of LT XLPE AB Cable of size 3CX95+70 sq. mm.
