A detailed Rate contract for supply of 10,218 MT of RS Joists 200 x 100 mm of various lengths and 9,027 MT of RS Joists 250 x 125 mm of various lengths was placed on you vide R.C No: 187 dt. 06.11.17 with delivery schedule of nine months

from the date of receipt of Rate Contract order.

In respect of the above RC, so far three indents were placed for supply of RS Joist vide Indent 1 dt. 09.11.17, Indent 2 dt. 18.11.17 & Indent 3 dt. 28.11.17. But

you have not commenced the supply and also not furnished SD cum performance

Due to non supply of materials, the Central Government Funded Schemes viz. IPDS, DDUGJY and UDAY schemes were held up and TANGEDCO could not commence the supply in time.

The reasons stated vide your letters under reference (5) cited against the show cause notice was not convincing and not acceptable. Also you have not taken any efforts to supply the materials as per RC terms and conditions.


From the above, it is clear that you had failed to supply the materials as per the rate contract and also had given false assurance for supply of materials resulting in acute scarcity of RS Joists and have revealed your poor performance & negligence towards supply of materials against the R.C No: 187 dt. 06.11.17.

Further, the subject rate contract no: 187 dt. 06.11.17 was cancelled with a levy of part penalty amount of Rs.27,54,15,570/- and you were requested to remit the above penalty amount to TANGEDCO vide our letter under reference (6) cited. But you have not remitted the above amount till date.

The matter has been considered by the Competent Authority and it has been decided as under:

"The firm M/s Mahamaya Steel Industries Ltd., having Corporate Office at B/8-9, Sector C, Sarora, Urla Industrial Complex, Raipur - 493 221, Chattisgarh is hereby banned from participating in future tenders with TANGEDCO, TANTRANSCO & TNEB Ltd. for a period of three years from the date of issue of this letter."
