In continuation to above references, it is intimated that your firm had participated in NIT Airman No. 03/CMD-II/RGTPPF-2083 dated 03.09.2020 and 04/CMD-II/RGTPP/F-2077 dated 03.09.2020 issued by this office. An enlistment certificate no. 1282 dt. 05.04.2018 issued by SE/PWD B&R, Hisar Circle, Hisar was submitted by your firm for fulfillment of pre-qualifying criterion of said NITs. The said enlistment certificate supplied by your firm was got verified from the issuing authority and after verification, it was confirmed by the office of SE/PWD B&R, Hisar Circle, Hisar (issuing authority) that no such certificate was issued from their office.

Accordingly a show cause notice was served to your firm seeking explanation vide memo no. Ch- 16/RGTPP/CMD-II/F-2119 dated 11.01.2021. The reply dated 18.01.2021 submitted by your firm in reference to the said show cause notice was not found satisfactory. The above act of your firm has tantamount to loss of faith.

In consideration of the above facts, HPGCL decides that your firm is hereby debarrred/blacklisted from doing further business with HPGCL upto 13.04.2022 for supplying forged documents against the subject cited NITs.

This is without prejudice to any other rights and remedies available to HPGCL
