Dear Sir,

This has reference to PO No. 2870 dtd. 14.11.2017 placed to your firm for supply of 102 Nos. 200 KVA rating, 11/0.433 kV Class Distribution Transformers, having Energy Efficiency level '2' against TS No. 02-03/ED(S&P)/616 (opened on 07.06.2017).

Clause no. 4 - delivery schedule' of the purchase order is reproduced herewith -

"(i) The supply shall be commenced within two months from date of issue of detailed order and supply of following quantity shall be completed upto March'2018 thereafter in equal monthly installment :-

200 KVA - 48 nos.

(ii) Supply of balance order quantity shall be completed in three equal quarters from April'2018.

However, delivery can be deferred/advanced as per our requirement i.e. delivery can be rescheduled."

Accordingly, you had to complete the supply of 48 nos. 200 KVA transformers upto March'18.

However looking to stock position & field requirement, the delivery Schedule of quantity at sr. no. (ii) of delivery clause i.e. balance 54 nos. 200 KVA rating distribution transformer was extended for 02 months from dtd. 18.06.2018 & then further extended by 01 month upto 18.07.2018.

Accordingly, you had to complete supply of balance quantity i.e. 54 nos. 200 KVA Dist. Transformers upto March 2019 as per revised delivery schedule.

You have however supplied only 43 nos. 200 KVA transformers out of the total ordered quantity against the P.Order placed on you. Last Dispatch Instruction was issued vide this office letter no. 4935 dtd. 05.12.2019 for supply of 05 nos. 200 KVA DTRs but you did not supply the same to A/stores even though the material was ready in all respect .You had also offered 22 Nos. transformers on 15.11.2019 for stage inspection which was duly conducted and for which stage inspection clearance was issued on 05.12.2019 but material was never offered for final inspection by you, till date.

Due to non-supply of required transformers by you, unwanted crisis of 200 KVA DTRs was created and many targetted got adversely effected.

Hence, reminders were issued to you vide this office letter No. 54 dtd. 03.01.2020, & No. 450 dtd. 27.01.2020 and you were directed to complete the supplies against referred Purchase Order. You were also advised that in case of failure to fulfil contractual obligations, penal action shall be initiated by this office. In reply to the notice, you sent an e-mail dated 06.02.2020, requesting to allow 02 months time to resolve certain issues relating to GST, being faced by you. Thereafter, nationwide lockdown was imposed in March'2020 which ended in June'2020. The matter was again taken up with you but you did not provide any satisfactory reply regarding completing the supplies.

Hence, due to non supply of balance 59 Nos.200 KVA transformers by your firm, a final notice was issued to you vide this office letter no. 3202 dtd. 07.08.2020. In reply to this notice you sent another e-mail dtd. 24.08.2020 saying that due to lockdown you were unable to supply the balance quantity of DTR against the pending order earlier and requested to extend delivery period by 06 months, waiver of penalty & permitting PV etc.

Since nearly 04½ years had passed since placement of P.O. and as no effort was made by you for completion of supplies in-spite of constant persuasion and giving sufficient time to you and in view of the scarcity of 200 KVA transformers for completion of targetted works, your request for providing further delivery extension along with revised PV could not be considered.

Therefore, a final notice vide no. 02-03/CE(S&P)/ACEP/ SEPII/EEP-III/ DTR/ TS616/1057 dtd.01.03.2021 was issued to you, to furnish reason for non-compliance of contractual obligation, within 07 days, failing which penal actions shall be taken against. However, you did not submit any reply to the above notice within stipulated time.

Above actions of your firm is a major default as due to non supply of much needed 200 KVA DTRs, created scarcity of transformers in field and many targetted works have suffered.


Therefore, following penal action as approved by competent authority is imposed against M/s Ramakrishna, Electricals Limited UIDC, Nagpur as per terms and conditions of tender / order and as per final notice issued to them vide T.O. no. 02-03/CE(S&P)/ACEP/SEPII/EEP-III/ DTR/ TS616/ 1057 dtd. 01.03.2021 :-

- i) To cancel the purchase order No. 02-03/CE(S&P)/2870 dtd. 14.11.2017 for supply of balance unoffered/unsupplied 59 nos. 200 KVA rating (Aluminium wound) 'ISI Marked' 11/0.433 kV Class Distribution Transformers having Energy Efficiency level '2 against TS No.02-03/616 opened on 07.06.2017. You are required to deposit an amount of **Rs.10,63,663.03** towards liquidated damages (10% of @ Rs 180281.87*59) being 10% of value of unfulfilled order (excluding of GST) with imposition of penalty (maximum penalty of 10% of value of order) in accordance with penalty clause -6.2 of order & as per clause 26 (26.1 to 26.06 of Annexure-B) of tender specification which is recoverable from EMD, security deposit available with CSPDCL and pending bill, if any or same shall be recovered from you by forfeiting your SD-BG, available with CSPDCL for Rs. 18,38,875.00 against the purchase order no. 2870 dtd. 14.11.2017.
- ii) To withdraw facility of exemption from furnishing of EMD on the basis of NSIC registrations in future participation in CSPDCL's tender's for a period of 03 years.
- iii) To debar M/s Ramkrishna Electricals Limited, N-5, Hingna, M.I.D.C., Nagpur 440016 from doing business with CSPDCL for three years or till recovery of assessed penalty amount stated above sr. no. (i), whichever will be later.


