Sub: Debarring of M/s Raghvendra Singh, Birsinghpur Pali-Distt.-Umariya (MP) due to unethical practice and committed breach of trust causing loss to the public exchequer.

Dear Sirs,

The erection contract for construction of 132 kV DCS line from Loc. No. 33 of 132 kV Satna (220 kV S/s) - Satna Cement line to Majhagawan S/s and 2nd circuit stringing of 132 kV Satna Cement line upto Loc. No. 33 while other circuit is charged was awarded on your firm vide order No. 04-06/C/T-540/2876 dated 12.12.2006 for Rs. 149.91 lacs.

You were apprised of the fact vide communications dated 10.6.2022, 20.6.2022, and recently, on 4.5.2022 and 23.5.2022 one number tower each at location No. 105 & 109 was up-rooted along with foundation.

As per the terms and conditions of the contract, it was the responsibility of the contractor to construct the line as per the technical specification of the order. The clause 25 "Responsibility of contractor", of Section-II "General Conditions of the contractor" of C.E. (EHT-C&M), MPPTCL tender specification no. T-540 stipulated as under:-

"The contractor shall be responsible for carrying out the works covered under the scope of the contract according to the specifications/order.

For example all the work of erection, should be done according to the specification / order and profile / drawings i.e. the tower should be erected according to the position indicated in the approved profile and the selection of foundation in various type of soil should be done based on the soils actually encountered in the foundation pits. Deviations, if any, from the approved/ specified conditions shall be brought to the notice of the C.E.(EHT-C&M), MPSEB, Jabalpur through site Engineer, before taking up the work and his decision shall be final and communicated through site Engineer. If at a later date, it is found that the contractor has carried out some work, not according to the specifications and without taking specific approval then in that case, all the payments made to the contractor for carrying out such works shall be recovered and the contractor will have to rectify the same at rate indicated in the order for carrying out such work without extension of time."

4/ As per the investigation, conducted on 5.5.2022 & 24.5.2022 and panchnama report, copy whereof was sent to you, it was found prima-facie that the cause of collapsing of tower was improper, inferior, substandard, negligent and poor quality of work and non-casting of foundation as per desired and approved technical specifications and the applicable drawing etc. and due to the reasons that the norms as prescribed were given a complete go-by while carrying out the foundation work (underground) as a sequel to which the collapse of the towers have taken place. The kind of work and the shortfalls came on surface and unveiled only upon the incident of collapsing of towers took place.

5/ Thus, prima-facie It is evident due to such kind of act, work, conduct and omissions while carrying out and executing the construction in question, you willfully cheated and deceived the MPPTCL, with an ulterior intention to gain profit unlawfully thereby causing loss to the Company and the public exchequer, apart from causing great inconvenience to the esteemed consumers of Discoms, Railways etc. having resorted to unethical practice and committing breach of trust reposed by MPPTCL on you.

6/ The panchnama report alongwith photo graphs was also sent to you. In response, you have intimated vide letter No.RSC/22-23/05 dated 22.6.2022 that the work was carried out by them 13 to 14 years back and guarantee period has been expired. You have further intimated that neither you have

been informed about uprooting of towers nor they have been called for inspection, hence the firm is not responsible.

7/ In response, you were asked vide this office letter No.676 dated 13.7.2022 to intimate your programme by 20.7.2022 to visit site for inspection in presence of both parties and also inspection of near by locations but you have neither conveyed any programme nor replied to our letter dated 13.7.2022 which was sent through e-mail and also through registered post.

8/ A notice for debaring has been served to your firm vide e-mail dated 2.8.2022 and through registered post vide this office letter No.798 dated 2.8.2022. You have given reply to our notice vide your letter dated 26.8.2022 received through e-mail dated 27.8.2022 in which you have mentioned that tower at location No.105 and 109 was collapsed due to thunderstorm and due to bending of tower and quality of towers. You have further intimated that neither you have been informed about Panchnama nor called for inspection, hence you are not in a position to say something in this regard. You have mentioned that work was carried out according to the rules. Hence, notice for debaring for three years without any basis is not proper. Hence, you have requested not to debar your firm for three years and maintain good business relationship.

9/ It is observed from your reply that you are silent about offering any comment on uprooting of towers with foundation which is a serious lapse. Further, you have been asked vide letter No.676 dated 13.7.2022 to intimate your programme by 20.7.2022 to visit site for inspection in presence of both parties and also inspection of near by locations but you have neither conveyed any programme nor replied to our letter dated 13.7.2022 which was sent through e-mail and also through registered post. Hence, sufficient opportunity was given to your firm for inspection of site and offering your comments, but you have failed to give convencing reply.

10/ It is therefore, decided that your firm **M/s Raghvendra Singh, SPO-17, MPSEB Colony, Prakash Nagar, Birsinghpur Pali-Distt.-Umariya (MP)** is hereby debarred from all future business with Madhya Pradesh Power Transmission Company Limited, Jabalpur for a period of 03 years with intimation to all SEBs/ Discoms/ Power utilities, and Central Electricity Authority.
