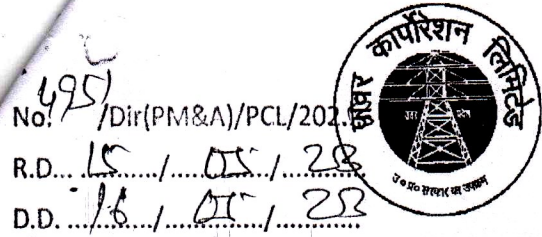

As per CFO, MPPKVCL, Indore letter no. CBPC/2017-18/619 Indore dated 03.08.2017, as per A.G. Audit, the labor Cess recovery of amount Rs. 33,08,867/- was balance to be recovered from you under Feeder Separation Project. You were written to deposit aforesaid recovery amount vide this office letter no. MD/WZ/FSP/16621 dated 18.08.2017. You were also reminded for same vide this office letter no. MD/WZ/FSP/8150 dated 21.04.2018, but you did not deposit the above outstanding amount. Against this outstanding, an amount of Rs. 11,43,123/- have been recovered through encashment of available Bank Guarantees of yours and Rs. 21,65,744/- is outstanding against you under this head.


Thus total outstanding liability against you is Rs. 94,38,078/-. However, you did not deposit the above outstanding amount to this office nor submitted any suitable reply/response.

Further, CGM (Rural Project), MPMKVVCL, Bhopal also made communication with you vide letter no. 8527 dated 24.12.2020 regarding the matter and requested you to submit your representation to this office. However, you neither turn up to this office nor have submitted any representation till date.

In view of above, you were finally reminded vide this office letter no. MD/WZ/DDUGJY/2022-23/11691 dated 22.08.2022 to deposit above outstanding amount against reference work orders under various heads within 07 days from the receipt of the letter positively and you were written to note that failing above, the appropriate action as per the terms and conditions of the award such as blacklisting of your firm should be initiated. This letter was sent to you vide Regd. A.D., however, the same was returned by post to this office unclaimed. The reminder letter (along with all previous letters) was also mailed to you vide e-mail on dated 23.08.2022 to your e-mail ids anandelectricals12@gmail.com and anandelectricals@gmail.com, however no any response received from you regarding the matter.

Hence, you are in breach of your obligations as per the integrity pact executed between you and MPPKVVCL, Indore under reference work orders. In view of above, the show cause notice for Debarring/Banning of your firm "M/s Anand Electricals, New Delhi" vide this office letter no. MD/WZ/DDUGJY/2022-23/15443 Dated :10.11.2022 was served upon you- "that why not your firm "M/s Anand Electricals, New Delhi" be banned for future business with MPPKVVCL, Indore for a period of 3 years" for neither depositing the outstanding amount against you as detailed above nor submitting your representation to this office regarding the matter". However, the same has been returned by post to this office unclaimed. Further you were reminded to reply against show notice vide this office email dated 24.11.2022. However, in spite of all above correspondences, you have neither deposited the outstanding amount against you as detailed above nor submitted any reply/representation to this office regarding the matter. It is, therefore, presumed that your firm has nothing to say for the default and failure in clearing the outstanding liabilities against you.

In view of all above facts and figures, you are in breach of obligations as per the integrity pact executed between you and MPPKVVCL, Indore under reference work orders, therefore, your firm M/s Anand Electricals, New Delhi 415-16, DDA Building No. District Centre, Janakpuri, New Delhi - 110058" is hereby Debarred/Banned for future business with MPPKVVCL, Indore for a period of 3 years from the issue of this letter.




