Subject: Memo No.: 818 /HD-603/QQ-1296/PO/C&S dated 03.02.2020 for the Purchase Order (PO) No. HD-603/QQ-1296/PO/C&S dated 03.02.2020 for the procurement of Flat Twin core PVC Cable of size 2Cx6 sq.mm placed on M/s Neeraj Cables Delhi - Cancellation of PO for balance supply, forfeiture of security & suspension of business dealings thereof.

The subject cited Purchase Order No. HD-603/QQ-1296/PO/C&S dated 03.02.2020 & Amendment No. 1 to PO dated 07.09.2021 for the procurement of Flat Twin core PVC Cable of size 2Cx6 sq.mm was placed on your firm. It is informed that your firm has failed to complete the supplies against the above PO despite of repeated reminders. Also, 21 days' notice was served upon your firm under "Negligence & Default" clause of purchase order vide this office Memo no. 1656/HD-603/PO/C&S dated 27.07.2022 and Memo no. 2086/HD-603/PO/C&S dated 20.09.2022, however no inspection call for balance material nor any response was received from your side. Hence, the firm has failed to complete the supplies as per respective provisions of the above referred purchase order. Further, your firm was given final opportunity of personal hearing before CE/MM ahead of procedure of action to be taken as per Negligence and default clause of PO is initiated vide Memo no.2880 dated 27.12.22 on 30.12.22 at 12 P.M. However, neither any representative of your firm presented itself for personal hearing nor any intimation (telephonically or through e-mail) was received from your side.

The matter was considered by the competent authority of PSPCL and it has been decided as under:

P.O. No. HD-603/QQ-1296/PO/C&S dated 03.02.2020 placed on M/s Neeraj Cables, Delhi is hereby cancelled for balance supply of 2Cx6 sq.mm LT PVC Cable i.e. 173.780 Km.

Security amount of Rs 2,20,140/- (Two Lakh twenty Thousand one Hundred & Forty only) lying with MM Organization of PSPCL towards 3% Security against PO No.HD-603/QQ-1296/PO/C&S dated 03.02.2020 deposited by your firm is hereby forfeited.

Business dealings of PSPCL with your firm is hereby suspended and your firm is blacklisted for a period of three years from the date of issue of this letter.
