The Nigam wishes to draw your attention towards 4 no. purchase orders i.e. HDP-1912 dated 25.01.2013, HDP-1985 dated 13.02.2014, HDP-1988 dated 28.02.2014 and HDP-2052 dated 04.03.2015 for supply of 11kV 15 Panel Board VCBs, which were placed upon your firm M/s Megawin Switchgear Pvt. Ltd. The detail of purchase orders is provided here under: -

The 11kV 15 Panel Board VCBs were to be supplied against above mentioned P.Os as per HVPNL's technical specification bearing No. HGD/S-58/R-7 (B)/DGM-89. As per

प्रस्त प्रचर के स्वार्ध All relays shall conform to the requirements of IS: 3231/IEC-60255/IEC 61000 or other applicable standards. Relays shall be suitable for flush or semi-flush mounting on the front with connections from the rear. All protective relays shall be in draw out or plug-in ype modular cases with proper testing facilities. Necessary test plugs/test handles shall be supplied loose and shall be included in contractor's scope of supply.

All main protective relays (viz Over Current and Earth Fault, Restricted Earth Fault, Over Voltage and Neutral Displacement) shall be numerical type and communication protocol shall be as per IEC 61850. Further, the test levels of EMI as indicated in IEC 61850 shall be applicable to these.

For numerical relays, the scope shall include the following:-

a. Necessary software and hurdware to up/down load the data to/from the relay from to personal computer installed in the substation. However, the supply of PC is not covered under this clause.

The relay shall have suitable communication facility for future connectivity to SCADA. The relay shall be capable of supporting IEC 61850 protocol (with

optical port)."

- However, it was found that the relays supplied by your firm on the 11kV Panel Board VCBs supplied against subject cited purchase orders, are not compatible with IEC 61850 protocol.
- 4. Vide memo no. Ch-23/QDP-1049/XEN/S/Stn.(P) dated 06.01.2017, your firm was requested to offer the relay compliant as per technical specifications of Nigam in all respects including fully supporting IEC 61850 (communication).
- 5. Your firm vide letter no. MSPL/13868/UT/DL/14-15 dated 31.01.2017 submitted as under:-

"We hereby give undertaking that all the relay provided on 11 kV panel sets supplied against PO No. HDP 1912 dated 25.01.2013, HDP-1985 dated 13.02.2014, HDP-1988 dated 28.02.2014 and HDP 2052 dated 04.03.2015 will be replaced/modified with the relay having IEC 61850 protocol during next one year."

However, your firm failed to replace/ modify the above relays.

- Again Nigam vide letter memo no. Ch-53/HDP-2052/QDP-967 dated: 18.07.2017, Ch-54/HDP-2052/QDP-967 dated: 20.09.2017, Ch-73/HDP-2052/QDP-967 dated: 18.09.2018 & Ch-89/HDP-2052/QDP-967 dated: 13.12.2018 had requested your firm to supply the schedule for the replacement/modification of the above relays in 11 kV VCB Panels supplied against subject cited P.Os to make compatible with IEC-61850 communication protocol at the earliest. In response, your firm vide letter no. MSPL/Uty./HVPNL-IEC 61850/RS/2018-19 dated 05.12.2018 has submitted the proposal as under:
 - a. "By adding Optical Port, we are honoring our commitment given by us vide letter dated 31.01.2017, we request HVPNL to accept our proposal for providing optical port and give clearance so that work can be completed in two months from date of receipt of confirmation from HVPNL.
 - b. We will also supply necessary software in the form of CD for up/down load the data to/from the relay from/to personal computer installed in the substations."
- Nigam vide letter memo no. Ch-33/HDP-2052/QDP-967/Vol-III dated 20.05.2019 had requested your firm to provide/replace the above relay with IEC-61850 communication protocol as per technical specification of HVPNL within six months with clear stipulation that in case of failure 10% Performance Bank Guarantee available against purchase order No. HDP -1912 dated 25.01.2013, HDP-1985 dated 13.02.2014, HDP-1988 dated 28.02.2014 and HDP- 2052 dated 04.03.2015 will be forfeited.

In response to above, your firm vide ref. MSPL/Uty. /11845/SS/2019-20 dated: 10.10.2019 has intimated that "considering our long relationship with HVPNL, our management has decided to conclude the issue with a solution." Your firm has also intimated that they are developing the necessary hardware/software modification, for the relay model supplied vide the above four P.Os to support IEC 61850 protocol and the testing is in progress.

8. As it was admitted by your firm that it did not have the software at the time of bidding and has failed to provide the solution even after 2.5 years from the date of commitment, the 10% Performance Bank Guarantee submitted by your firm against above mentioned 4 no. P.Os was encashed on dated 08.11.2019 as per Clause-6(IV) of SCHEDULE-D of contract (Earnest Money/Performance Guarantee). Clause-6(IV) of SCHEDULE-D is reproduced here under for reference:-

"If supplier fall or neglect to observe or perform any of his obligations under this contract, it shall be lawful for purchaser to forfeit either in whole or in part, in his absolute discretion, the security deposit furnished by the supplier."

- Further, refer to your letter MSPL/HVPNL/Uty./13071/Relays/SS/ 2022-23 dated 24.05.2022, vide which it has been requested by your firm to review penalty levled/imposed against subject clted 4 nos. P.Os for supply of 11kV 15 Panel Board VOBs and out of court settlement and also refer to your letter MSPL/HVPNL/Uty./13071/PM/ConLtr/2022-23 dated 28.12.2022, vide which you have submitted an affidavit on non-judicial stamp paper regarding the consent on the following proposal:
 - a. Payment of the difference of price between the relays having communication protocol of IEC-61850 (i.e. Relay ordered) and relays supplied having communication protocol of MODBUS i.e. an amount of Rs. 1,19,46,792.00 (Rs. One Crore Nineteen Lacs Forty Six Thousand Seven Hundred Ninety Two Only).

 Non-claiming of any interest /damage/compensation etc. on any count in court of law including Arbitration.

c. Out of court settlement with HVPNL as full and final settlement between the parties and to disposed of the court case on the basis of settlement to be arrived at between the parties.

2. The BODs HVPNL has approved the above proposal as mentioned at sr. no. B.1 (a, b & c). However, since your firm failed to comply with the technical specifications & adhere to the terms & conditions of contract agreement, which clearly shows negligence on part of your firm towards execution of P.Os. Therefore, BODs HVPNL also approved that your firm shall be blacklisted for the next one year for non-complying with the technical specifications while supplying the material to the Nigam.

In view of above mentioned facts, it is clear that your firm failed to comply with the technical specifications while supplying the material to the Nigam as per terms and conditions of contract.

Besides above, on account of unlike business behavior and unappreciable approach of your firm toward execution of POs issued to your firm, a notice of 15 days was served as to why your firm may not be blacklisted/debarred for one year for doing future business with HVPNL vide Memo no. Ch-101/HDP-2052/Xen/S/Stn(P) dated: 26.06.2023.

Your reply received vide e-mail dated:06.07.2023, in response to this office's above mentioned letter regarding blacklisting is not found feasible for acceptance as it is clear that your firm failed to honour the contract in true spirit.

Therefore, your firm is blacklisted/debarred for one year for participating in future tender enquiries with HVPNL.

This is without prejudice to other rights of the Nigam.
