**Subject: Debarring/Blacklisting of M/s Infinity Construction and Engineers, Barwala, Hisar for a specific period for non-compliance of labour laws and failing in providing services to HPGCL.**

In reference to above, your firm was issued the work order for the work of cleaning of drains and sweeping of roads, paths and cleaning of trash rack at CW pump house, cooling tower, raw water pump house, cleaning of splash nozzles/End plugs/walkway, stairs, railing etc. and work of 24 X 7 water supply in plant and non-plant buildings at RGTPP, Khedar vide work order No.3/Ch-39 /XEN/CMD-1/RGTPP/2022-23/F-669,Dated 20.04.2022 for the period from 01.04.2022 to 31.03.2023 extendable by 3 Months. The Contract was extended from 01.04.2023 to 31.07.2023 (3 Months) on the same rate and terms and conditions.

On 11.05.2023, a complaint was filed to ALC, Hisar by the contractual workers engaged by your firm against the said work order regarding the nonpayment of wages, EPF, ESI and LWF.

The firm was held responsible for:-

- A) Violation of labor laws as the firm has not paid the wages to workers for long time and has not paid wages to workers within 7 days of completion of wage month as per payment of wages act, 1936.
- B) Violation of EPF Act as the firm has failed to submit the proof of deposition of EPF.
- C) The firm has failed to provide the services stipulated in the work order timely to HPGCL.
- D) Failure in compliance of undertaking given twice by the firm at the time of submission of Bills regarding submission of EPF, ESI, LWF, wages proof.

A show cause notice was issued to your firm vide this office memo. No. 102/XEN/CMD-1/RGTPP/ F-669 dated 19.05.2023 to explain in writing that why the firm be not blacklisted for violation of labor laws and non-compliance of undertaking given by the firm. But your firm did not submit any reply to the show cause notice and thereafter, an opportunity of personal hearing was granted to your firm on 29.05.2023 before the Project SPC. During the hearing, the following points were observed by the Project SPC:-


- A) The performance of the firm is very poor against the said work order.
- B) The contractor has default in timely payment of wages to the workers and compliance of various statutory laws.
- C) Firm has not provided equipment / non completion of works within stipulated period.
- D) The firm has provided JCB only for 867 hours out of 2100 hours which is just 42.24% of the obligations to be made by the firm as per the work order.
- E) Failure in compliance of undertaking given by the firm at the time of submission of bills on dated 27.01.2023 and 15.05.2023 regarding submission of EPF, ESI, LWF, wages proof & attendance sheet etc.

Project SPC issued final warning to the firm and directed to comply all the statutory requirements immediately and improve their performance with immediate effect. Firm was also directed to submit the documentary evidences of all the statutory compliances up to 03.06.2023 as requested by the firm but the firm failed to submit the documentary evidence of statutory compliances.

Looking to the all above facts HPGCL has given enough/sufficient chance/ time to firm. HPGCL considers that the firm has violated Clause no. 9, 16, 31 and 35 of W.O. No. 3/Ch-39/XEN/CMD-1/RGTPP/2022-23/F-669 dated 20.04.2022 and also failed to meet its commitment to submit required compliances. In consideration of the above facts, HPGCL decides as under:-

- A) To debar/blacklist the firm M/s Infinity Construction and Engineers, Barwala for a period of two years for doing further business with HPGCL.
- B) To reject the firm from participating in HPGCL tenders which are under process and have not yet matured.
- C) Not to release the Security deposits of the firm within HPGCL until it clear all the statutory requirements as per work order and its terms & conditions.

This is without any prejudice to HPGCL's rights in terms of the tender and otherwise.


