SE/OP circle Palwal vide his office memo no. 4232 dated 31.05.2023 has intimated that Deputy Commissioner, Palwal vide office memo no. 2362 dated 25.05.2023 has directed to take immediate necessary action for blacklisting etc. against Sh. Umesh Contractor Prop. of M/s UMC Company, Palwal who is empanelled as electrical contractor of EOI under DHBVNL, as per enquiry report conducted by SDM Palwal.

In this regard, it is intimated that the CM Window complaint was lodged by \$h. Ravi Rawat S/o Sh. Shakti Singh Rawat, R/o H. No. DK-128, 4 Civil lines, Palwal vide Regn. No. CMOFF/N/2022/09417 & CMOFF/N/2022/115848. The complainant has further made complaint to the Deputy Commissioner, Palwal for no action against his CM Window complaint. Deputy Commissioner Palwal got the complaint inquired from Sub-Divisional Magistrate Palwal SDO/Operation sub-division Deeghot vide memo no. 251 dated 06.04.2023 obtained the inquiry report from SDM, Palwal and Deputy Commissioner Palwal vide his office memo no. 2362 dated 25.05.2023 further directed to take immediate necessary action as per the inquiry report conducted by SDM, Palwal.

Further, it is intimated that your firm i.e. M/s UMC Company, Palwal was empanelled in EOI-24E by this office vide memo no. Ch-366/EOI-24E/PD&C/2022-23 dated 28.10.2022. Your firm have also participated in EOI-26E for empanelment as an approved . प्रवन्ध निर्देशक contractor to execute the works upto 11 kV under the jurisdiction of DHBVN. Since, your firm र प्रदेश पायर कारपोरेशन लि॰ Was already empanelled in EOI-24E, as such, your firm was exempted to submit the technocommercial documents against EOI-26E and qualified for opening of price bld. Accordingly, the price bids of qualified bidders including your firm i.e. M/s UMC Company, Palwal, were opened

on 29.05.2023.

Clause no. 60 of "Conditions of Contract" of EOI-26E bidding document is reproduced as under: -

## 60. Blacklisting of the Firms:

The contractor will be blacklisted,

- 1. If the Enlisted firm backs out of the contract at any stage, the firm will be issued two 15 days' notices to commence the work failing which no further notices will be issued and the firm will be straightway Blacklisted, without prejudice to other terms and conditions of the contract.
- 2. If the firm Indulge in fraudulent and illegal practices such as forgery. cheating or any civil/criminal wrongdoing or any grave misconduct of similar nature which has a direct impact on the contract and the Nigam. In such case no notice of default will be issued and the firm will be straightway blacklisted in addition to initiating the legal proceedings etc., without prejudice to the other terms and conditions of the contract.
- 3. If the Enlisted firm fails to complete the work within the delivery/completion schedule, the deduction of the penalty will commence as per the terms and conditions of the present Bid Documents. On deduction of the complete penalty as admissible, the Enlisted firm will be issued one 15 days' notice to complete the work failing which the Performance Bank Guarantee will be forfeited. Subsequent to the above two 15 days' notices will be issued and the firm will be blacklisted thereafter.

The Performance Bank Guarantee of the Biacklisted firms will be forfeited and the firm shall have no claim whatsoever on the same.

However, Procedure and other conditions of contract are regulated by procurement manual of DHBVN, so, these will be applicable to the Enlisted firm as per procurement manual of DHBVN and amendments thereof from time to time.

Keeping in view the above facts & as per clause no. 60.2 of bidding documents of EOI, your firm M/s UMC Company, Ram Nagar, Palwal is hereby blacklisted for a period of 03 years for executing all types of works under the jurisdiction of DHBVNL as per recommendations of the DC. Palwal as your firm has been found to be involved in fraudulent and corrupt activities.

This is, however, without prejudice to the actions admissible to be taken under the other terms and conditions of the contract/ bidding documents.
