Sub: Regarding cancellation of WO No. 185 dt 27/10/2021 and Blacklisting/Suspension of business dealings.

Dear Sir,

You were enlisted as A-Class contractor as per approval given by Chief Engineer/TS, PSPCL, Patiala vide memo no. 3727 dt. 29/07/2023. Work order No 184/TL Circle/PTA/2021-22 dated 22.10.2021 and No 185/TL Circle/PTA/2021-22 27.10.2021 respectively were issued for the work of 66 KV T-off line from Handyaya-Mehal Kalan idle line for New 66 KV S/S Jhaloor and Stringing of 2nd circuit on existing tower line from 220 KV GSS Dhanaula to 66 KV S/S Badrukhan respectively. For these works material was issued under various SR's from PSPCL stores. On dated 24.04.2023 a Joint team of officers of PSPCL detected that the material issued against the above PSPCL works subject to terms, conditions and clauses of work orders was presented for inspection by you for NHAI work.

On this detection PSPCL initiated an inquiry into the matter and report was submitted to the competent authority. Among other decisions it was decided that:

"4. Immediate action to be taken by the O/o CE/TS against M/s Munish Kumar Contractor for misappropriation of PSPCL material and giving the same to M/s Victor Infra for NHAI work, in line with the provisions of the work order (against which material was issued to him)/ Works Regulations in a time bound manner.

5. Matter be taken up by CE/TS with NHAI at the highest level clearly conveying that M/s Victor Infra did not purchase any conductor from M/s S.R Impex Jalandhar & PSPCL material was misappropriated from PSPCL Contractor M/s Munish Kumar Contractor for NHAI work.

Your explanation was called vide memo no 3199/3201 dt 13/09/2023 to showcase/explain your conduct as to why action should not be initiated against you for violation of relevant clauses of above work order/Work Regulation. The explanations put forth by you vide your letter dated 15/09/2023 was found to be unsatisfactory by the competent authority for violation of various conditions/Work regulations including Guarantee for Board's Material & Forfeiture of Security Deposit reproduced as under

" 2.8 GUARANTEE FOR BOARD'S MATERIAL: The board will issue materials for use on works as detailed separately. The contractor shall furnish the Board with a guarantee that materials supplied by the Board to the contractor will be used exclusively for the work for which issued and for other auxiliary works such as construction of storage sheds, field offices, staff/labour quarters and warehouse, tool room etc. The Contractor shall be responsible for the loss, destruction or deterioration of the material supplied to him by the Board, even if such loss, destruction or deterioration has occurred under any circumstances whatsoever beyond his control as the materials so supplied were his property.

24 (C) FORFEITURE OF SECURITY DEPOSIT: In the event of default on the part of Contractor in the faithful execution, the security deposit shall be forfeited by an order of the Contracting Agency under intimation to other SEs, CEs and Secretary Board. In the case of field Sr. XENs, an order of forfeiture of Security deposit shall be issued by them provided they are Contracting Agency, under intimation to their SE,s who in turn shall circulate the same to other SEs CEs and Secretary Board.

The forfeiture of security deposit shall be without prejudice to any other rights arising of accruing to the Board under relevant provision of the contract like penalty/damages for delay in delivery of risk execution of work including suspension of business dealings with Board for a specific period."

Accordingly, the matter was put before the Whole Time Directors of the PSPCL has decided:

- To Blacklist / suspend business dealings with M/s Munish Kumar Ghabdan, Distt Sangrur forever from the date of issue of letter in this regard.
- To cancel WO No. 185 dated 27.10.2021, placed upon M/s Munish Kumar Contractor.

Accordingly,

- a) Your firm / M/s Munish Kumar Contractor, Ghabdan, Sangrur is hereby blacklisted and business dealings with your firm suspended forever from the date of issue of this letter.
- b) WO No. 185 dated 27.10.2021, placed upon firm / M/s Munish Kumar Contractor is hereby cancelled.

This decision will be implemented with prospective effect and will have no effect on running work orders being executed by your firm.
