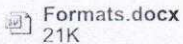

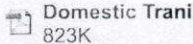

Annexure I**Methodology for selecting participants across different top borrowers**

- Utilities with Loan outstanding > 10000 crores- 10 officials per borrower with an exception for TN Discom considering loan book of more than 40,000 cr, double numbers (i.e. 20 officials) are considered.
- Utilities with loan outstanding between Rs.5000 crores to Rs.10000 crores- 8 officials per borrower.
- Utilities with Loan outstanding between Rs.3000 to Rs.5000 crores- 6 officials per borrower.
- Utilities with loan outstanding between Rs.1000 crores to Rs.3000 crores- 5 officials per borrower.
- Additionally, 10 officers from CPSU/JV Utilities & State Borrowers based on future business potential is also being targeted.

Standard Operating Procedures with Timelines

Initial Planning Exercise

- Regional Offices may intimate State Authorities and Borrowers tactfully in respect of the proposed training exercise along with proposed calendar. Proper dissemination of information regarding this program at highest level may be ensured for extracting maximum leverage and projecting REC as preferred lender.
- ROs may seek State Authorities and Borrowers consent as per the calendar and may obtain their nomination designation wise in advance (Quarterly Plan as per **Format I** and Individual training nomination as per **Format II**). Every Institute has a lead time of 30-45 days, hence planning and confirmation of the training module with exact data is to be finalised accordingly in advance.
- Utilities wise number of officials has been segregated, based on which segregation of category wise participant is to be sought from State Authorities. For instance, from Haryana Transco 5 officials are to be nominated -> Segregation of category wise officials as per training calendar is to be obtained from Haryana Transco. This will help in planning the training.
- **Special Mention:** Category 1 includes Board level officials and Senior officials of State Government department and therefore may be sensitised accordingly. ISB Hyderabad/IIM Bangalore/IIM Kolkata has been roped in for curating category 1 training and confirmation is required in advance to plan and design the training module.

Planning and Design

T (-) 45 days

- Based on calendar, BDM Division shall approach respective institute with appropriate lead time with information to SOP Division for planning and designing the program according to the category earmarked.

Nomination & Logistics

T (-) 20 day to T(0)/Training Day

- SOP Division to obtain final list of participants from the ROs and share the same with BDM Division for submitting to the Training Institute.

To help us plan and curate the training sessions in advance, a **Quarterly Nomination Form** is being shared herewith. Please fill it out with the number of participants from each category along with a brief background or designation and send it to your concerned REC Regional Office. *A separate nomination form for actual officials will be shared before the commencement of each training session.* If any nominated participant is unable to attend, replacement/back up name in equivalent level category wise be kept ready.

- Concerned ROs to make the travel arrangement (Flight charges for nominated state officials by concerned ROs and travel from Airport to Training Institute by respective ROs based on location of institute).

Execution

- Training Institute to deliver the program, manages all accommodation, and handles on-site logistics. The institute will also facilitate outbound site visits/industry visits as part of the curriculum if any planned & Concerned ROs to arrange for the transportation, wherever applicable.
- Institute to submit Invoice along along training feed back and BDM Division to process for Payment towards the institutes & SOP/ROs is required to collect the feedback.

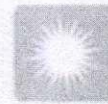
